The Sweetwater Mountain Bike Association (SMBA) has been diligently working on the expansion of the Wilkins Peak Trail System. We have finally gotten approval to build out our 20+ miles expansion plan that has been in the works for over a decade! This expansion will take us up and over Wilkins Peak to the Rock Springs side and back. It will eventually lead to a parking area up top with a BLM toilet and a trailhead with toilet at the base of Wilkins on the Rock Springs side. Partnerships with the City of Green River, The Bureau of Land Management (BLM), Rock Springs Grazing Association (RSGA) and the Forest Service, we are able to provide and promote these amazing trails.

We are in the middle of building out the trailhead with help from the Greenbelt Task Force, City of Green River and volunteers. There are some big-ticket items that we are raising funds for. A vault toilet (\$32,000+), covered shelter with picnic tables and BBQ grilles (\$20,000+), information center and more.

We are asking for your help with this year's 16th annual "Trails Day" event scheduled for June 12th, 13th, and 14th, as well as all the projects listed above.
